- o Overview of new rules:
 - o APPG secretariat must not be provided or funded by a foreign government (applicable from 16 October 2023)
 - o APPGs must have no more than four officers (from 31 March 2024)
 - o MPs may be an officer of a maximum of six Groups (from the start of the next parliament)
 - o All APPGs will need to approve an income and expenditure statement at their AGM (from 31 March 2024)
 - o APPGs receiving over £1,500 in the calendar year will be subject to additional requirements at their next AGM (from 31 March 2024), including:
 - An external chair, appointed by the Speaker to preside over
 AGMs and EGMs
 - A quorum of 8 parliamentarians
 - The publication and approval of an Annual Report setting out the work of the APPG
 - The publication and approval of a due diligence statement
