Meetings convened

Arms Trade Treaty Conference: prospects for an agreement (28 February 2013)

Speakers:

Minister Burt updated MPs and Peers on the UK's preparations for the imminent Arms Trade Treaty Conference (18-28 March 2013) and reaffirmed the UK's resolve to strengthen the draft treaty text that emerged from the inconclusive negotiations in July 2012.

The meeting was chaired by Lord Hannay and was jointly hosted by the United Nations, Global Security and Non-Proliferation and Weapons and Protection of Civilians APPGs.

Process for developing the post-2015 development framework (21 March 2013)

Speaker: Michael Anderson (DFID), the Prime Minister's special envoy on the post-2015 framework

As well as outlining the UK's role in devising the successor to the Millennium Development Goals, Mr Anderson described first-hand the workings of the UN's High Level Panel on the post-2015 development framework as well as speaking about the various opportunities for civil society and parliamentarians to engage with the process.

The UN's role in genocide prevention and R2P: theory and practice (15 April 2013)

A select group representing Government, civil society, the UN and academia discussed how far R2P had come since the World Summit in 2005, and how effective it was in the following four areas: early warning and monitoring for effective prevention; implementing prevention on the ground; intervening to protect: when and how?; and galvanising international political will for R2P.

The meeting was chaired by Lord Hannay and hosted jointly by the UN APPG, the APPG on the Prevention of Genocide and Crimes Against Humanity, the APPG on Global Security and Non-Proliferation and the APPG on Weapons and the Protection of Civilians.

The event was part of the International Development APPGs' "Parliamentarians Ending Poverty" series and covered the lessons to be learnt from the Millennium Development Goals, the merits of the goal-based approach from the perspective of the world's poorest countries, and the UK's vision for the future of international development and the framework required to support it.

The event was chaired by Hugh Bayley MP and was hosted by the All Party Groups on International Development, of which the UN APPG is an active member.

The Responsibility to Protect: Living or Dying? (15 May 2013)

Both speakers highlighted the progress made on establishing and consolidating the principle of R2P, and the challenges of implementing the policy framework it prescribes for preventing and responding to mass atrocity crimes.

The meeting served as the launch for UNA-UK's first policy briefing on R2P, written by Professor Alex Bellamy. The report clarifies the principle's meaning and scope and considers the steps required to implement the norm at the UN Headquarters, within national governments and as part of the international response to emerging crises across the world.
